# **Other Work**

#### Auto World Chanhassen

There is an auto salvage yard on the south side of Flying Cloud Drive in the City of Chanhassen. The owner of the property passed away earlier this year. The property was subsequently taken over by the State of Minnesota for no-payment of property taxes. The heirs of the property owner paid the property taxes owed on the property with the stipulation that the property get cleaned up. The owners are required to perform a phase II environmental investigation of the property and to survey the property to make sure they are within the property boundaries. The owners intend to continue operating the site as a salvage yard in compliance with the district court decision.

#### **Upgrala Gun Club**

The owner of the land that is used by Upgrala Gun Club in Eden Prairie contacted the LMRWD. He is interested in selling the land to an interested party. He had tried to convey the property to the US Fish & Wildlife Service, however they were not able to put a deal together. He is now working with BWSR and they have advised him to put the land into an NRCS program.

Most of the parcels of land are in the MN River floodplain. He has been allowing Sever Peterson to farm the parcels; however, crops have been flooded out more often than not in recent years, so little income has been realized and the taxes keep going up. The owner would like to transfer ownership so that he does not have to pay taxes any more.

#### Watershed Based Funding

The Minnesota River North group will hold its 3rd meeting July 14, 2020. The group is working on setting priorities for project funding in order to determine how funds will be allocated. Lower MN River North has been allocated \$673,699 for FY 2020/2021.

The Minnesota River South group will hold its 4th meeting Jul23, 2020. This group too, is working on setting priorities for project funding. Lower MN River South has been allocated \$829,075 for FY 2020/2021.

#### **One Watershed One Plan - Planning Area 56**

Le Sueur County has received the Resolution adopted by the LMRWD Board of Managers regarding the LMRWD's participation in the One Watershed One Plan process for Area #56. A meeting has been scheduled for 1:00pm on Wednesday July 15, 2020. The purpose of this meeting will be to determine the area that is included in the planning area.

#### Watershed District Signage

Manager Salvato inquired about signage that she has observed in other watershed districts. Other WD place signs on streets crossing creeks and some place signs at the watershed boundaries. Since all roadways crossing the MN River are State Highways, I did some checking with MNDOT. I did not get a very definitive response from them. They seemed to indicate that there would not be a problem putting signage identifying the MN River, however, they didn't say whether or not it could also have the Watershed District identified. Before spending a lot more time investigating what other watershed districts do, I thought I should check in with the Board. This can be an item for discussion with the 2021 budget discussion.

#### **Trout Stream Restoration**

On May 22nd, Della Young and I chatted with Representatives from Trout Unlimited. Trout Unlimited proposed a project to restore a trout stream in Dakota County. Since then Della and I had an opportunity to visit with Mark Nemeth of DNR Fisheries. Mark is very familiar with the trout streams within the boundaries of the LMRWD. He was not sure the value of restoration of the trout stream identified by Trout Unlimited, however, we did speak in general about the trout streams and agreed to meet with Mark again and other DNR Fisheries staff to talk about LMRWD trout streams; similar to the work the LMRWD did with the DNR on the calcareous fens. We plan to meet virtually, July 28th at 1:00pm. Future information will be reported under the Geomorphic Assessment Project.

#### **Technical Assistance for Residents in Hennepin County**

The LMRWD has agreements to provide technical services to residents in Carver, Dakota and Scott Counties. The Soil & Water Conservation Districts are able to provide this service and bill the LMRWD based on time and expenses. Hennepin County does not have a Soil & Water Conservation District. When residents of the LMRWD that live in Hennepin County call the District looking for advice, the District has no one to refer them to. I have had discussions with Hennepin County's Department of Natural Resources and we are looking at entering into an agreement with the County to provide services to Hennepin County residents that live in the LMRWD. Lately, I have had two residents of Bloomington call to ask for resources. Both live on the bluffs of the Minnesota River and are looking for information about removing invasive species and managing the steep slopes. The agreement will come to the Board for approval once it is ready.

# Watershed Plan Projects

**Gully Inventory and condition assessment:** Interns have been documenting gullies and ravines in the LMRWD. They have used the 2007 gully inventory as a basis for the work this summer. The previous inventory did not document any ravines or gullies on the south side of the river. This will be part of the budget discussion. The interns are planning to make a presentation of their findings to the Board at the August meeting.

**Eden Prairie Area #3 Stabilization** - LMRWD staff submitted an application for an Opportunity Grant from Hennepin County for this project. The amount of the grant requested was \$100,000. This project has been added to the LMRWD website.

**Seminary Fen ravine stabilization project:** The 2020 legislative session ended without an environmental bill having passed. A second special session has been called and began this week. As was report in the June Administrator's report staff visited the site during the field training with the interns and found silt

**Shakopee Downtown BMP Retrofit (Scott County Watershed Based Funding):** The City of Shakopee informed the LMRWD that they have an opportunity to install a BMP in downtown Shakopee at the Scott County Government Center. The City has said the BMO will provide regional treatment to an area of the City that has virtually no treatment currently. They did do a feasibility study separate from the grant and identified two good projects. They pursued one of the options last year and bid it as an alternative to the County project. However, they did not get a good bid. Based on the schedule for the County project they were not able to rebid that project. They are at the 90% design point on the second project. The County project will disturb less than one acre and is not in a High Value Resource Area or the Steep Slope Overlay Zone, so a LMRWD permit is not required.

**Carver County CSAH 10:** City of Chaska - This project is a Carver County Project within the City of Chaska. CSAH 10 is also called Engler Boulevard. The County is planning a transportation improvement project for CSAH 10 from the City of Victoria to its intersection with CSAH 61 in Chaska. LMRWD staff

LMRWD staff has been working with consultants for the City and staff from the CCWMO to permit this project and are planning a meeting to discuss the project.

**City of Burnsville - Freeway Dump and Landfill:** LMRWD met with the MPCA and consultants for this project on June 18, 2020. The topic of discussion was whether or not the project would need a permit from the LMRWD, whether or not the resulting new landfill should be considered impervious or not and how this project will impact the MN River floodplain. We are planning to meet again at 1:00pm on July 21, 2020. The project will need a permit from the LMRWD since Burnsville has not been approved for a municipal permit yet. The City is requiring the project to provide a no-rise certification. Decisions have not yet been made regarding the other two questions.
